Applications are invited Online only from qualified candidates for appointment in the under mentioned post in Kerala Government Service. Before applying for the post the candidates should register as per One Time Registration through the official website of Kerala Public Service Commission. Candidates who have already registered can apply through their profile.

1. **Department** : **Technical Education Department**
2. **Name of Post** : **Tradesman - Masonary**
3. **Scale of pay** : **₹ 26,500 – 60,700/-**
4. **Number of vacancies** : **3 (Statewide)**

The above vacancies are now in existence. The Ranked list published by the Commission in response to this notification shall remain in force for a minimum period of one year and maximum period of three years, provided that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year, or till the expiry of three years whichever is earlier. Candidates will be advised from the said list against the vacancies noted above and against vacancies that may be reported to the Commission during the period of currency of the Ranked list.

**Note :-** 4% of the total vacancies reported shall be reserved for eligible Differently Abled candidates with disabilities as specified vide G.O.(P) No. 5/2023/SJD dated 01.10.2023

5. **Method of appointment** : **Direct Recruitment**
6. **Age Limit** : **18 - 36.** Only candidates born between 02.01.1989 and 01.01.2007 (both dates included) are eligible to apply for the post with usual age relaxation to Scheduled Castes, Scheduled Tribes and Other Backward Communities, (For conditions regarding the age relaxation please see part II para 2 of the General Conditions) .

**Note :** Age relaxation will be allowed for officers of Technical Education Department to the extent of their service in the Department subject to a maximum period of ten years over and above the relaxation in age, if any, allowed under general rules. In such cases, the maximum age shall not exceed 50 years.

**7. Qualifications :**

- 1) A pass in Technical High School Leaving Certificate Examination with specialization in the appropriate Trade.

OR

- 2) (i) Pass in Secondary School Leaving Certificate Examination or Equivalent.

- (ii) National Trade Certificate in the appropriate Trade/ Pass in Kerala Government Certificate in Engineering Examination in the appropriate trade/ Pass in Vocational Higher Secondary Certificate Course in the appropriate Trade.

**Note :**

- 1) Rule 10 (a) (ii) of Part II KS & SSR is applicable.
- 2) In addition to the qualification prescribed in the notification, the qualification recognized by executive orders, or standing orders of Government as equivalent to the qualification specified for the post, in the Special Rules or qualifications found acceptable by the Commission in cases where acceptance of equivalent qualification is provided for in the Rules and such of those qualification which pre-suppose the acquisition of the lower qualification prescribed for the post, shall also be sufficient for the post. The copy of the Government orders declaring equivalent/ higher qualifications shall be produced as and when required by the Commission.
- 3) The Degrees/ Diplomas awarded by UGC approved Universities or Institutions established through an Act passed by Parliament/ State Legislative Assembly in accordance with the conditions laid down in G.O.(MS)No. 526/PD dated 17.07.1965 are acceptable for appointment in Government Services.

**Probation :**

Every person appointed to this post shall from the date on which he / she joins duty, be on probation for a total period of two years on duty within a continuous period of three years.

**8. Mode of submitting application :**

- (a) Candidates should send their application through the official website of the Kerala Public Service Commission [www.keralapsc.gov.in](http://www.keralapsc.gov.in) after One Time Registration. Candidates already registered can apply after logging in their own profile using their User ID and Password. Candidates must click on the '**Apply Now**' button of the respective post in the Notification Link to apply for the post. No application fee is required.
- (b) Candidates have to apply as per the conditions in this notification, General Conditions and as per the instructions given in the official website of Kerala Public Service Commission [www.keralapsc.gov.in](http://www.keralapsc.gov.in). The applications submitted not in accordance with the notification will be summarily rejected at any stage of selection. No further chances will be given to the candidates to cure the defects in the application.
- (c) Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure correctness of the information in their profile. They must quote the User ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. **Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the printout of the application by clicking on the link 'My applications' in their profile. All correspondences with the commission, regarding the application should be accompanied with the print out of the application.** The profile correction made by the candidates themselves or through the office of the Kerala Public Service Commission on request after the last date fixed for the receipt of applications will not be reflected in the application. Such correction will come into effect only on the date on which corrections have been made.
- (d) Candidates who have Aadhaar card, should add Aadhaar Card as ID proof in the concerned link in their profile.
- (e) **Candidates creating new profile shall upload photograph taken within six months.** Name of candidate and date of photo taken should be printed legibly at the bottom portion. The photograph once

uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in the other instructions regarding the uploading of photographs.

- (f) Original documents to prove qualification, experience, age, etc. have to be produced as and when called for.

**Note :** If written/ OMR/ Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and registered mobile number.

**9. Special Instructions to Candidates:**

- (a) In the case of difference in caste/community claimed in the application and that entered in SSLC book, the candidate shall produce a Gazette notification in this regard, along with Non-Creamy Layer/Community Certificate at the time of certificate verification.
- (b) Candidates are required to acquaint themselves with the instructions given in the notification as Part II, General Conditions before submitting application for the post. Applications which are not submitted in accordance with the terms and conditions laid down in the General Conditions are liable to be rejected.
- (c) Appropriate disciplinary action as per **Rule 22 of the Kerala Public Service Commission Rules of Procedure** shall be initiated against those candidates who submit applications with bogus claims of qualification regarding education, experience etc. and are liable to be disqualified for being considered for a particular post or debarment from applying to the Commission either permanently or for any period or the invalidation of their answer scripts or products in a written/practical test or the initiation of criminal or other proceedings against them or their removal or dismissal from office or the ordering of any other disciplinary action against them if they have already been appointed, or any one or more of the above.
